The application must be signed in the name of the limited partnership by a general partner. Any person may sign the application by an attorney-in-fact. As provided in § 50-73.15 C of the Code of Virginia, the execution of this certificate by a general partner constitutes an affirmation under the penalties of perjury that the facts stated herein are true.

A registered limited liability partnership may not serve as its own registered agent.

Attach a recently certified copy of the original limited partnership certificate filed in its jurisdiction of formation. If that document has been amended and restated, forward that document and any amendments to it.

Submit the original to the Clerk of the State Corporation Commission, P. O. Box 1197, Richmond, Virginia 23218-1197, or 1300 E.
